- SECOND Based on BI *Rate* Year 2010 referred to in the FIRST Dictum, a simple average BI *Rate* determined for the Year 2011 is 6.5%.
- THIRD The simple average BI *Rate* of 6.5% referred to in the SECOND Dictum is used for the calculation of License Fee (BHP) of Radio Frequency Spectrum Band of 2.1 GHz for the provision of cellular mobile network for the year 2011.
- FOURTH This Ministerial Decision shall come into force on the date of its issuance.
