Considering: .that based on the provision of Article 6B paragraph (4) and Article 6E of the Government Regulation of the Republic of Indonesia Number 76 Year 2010 on Amendment to the Government Regulation of the Republic of Indonesia Number 7 Year 2009 on Types and Tariffs of the Kinds of Non-Tax State Income Applicable at the Department of Communication and Information Technology, it is considered necessary to issue a Decision of the Minister of Communication and Information Technology on Defining the Amount and Time of Payment of the License Fee of Radio Frequency Spectrum of the Third Year for the License of Radio Frequency Spectrum Band for the Provision of Cellular Mobile Network at Radio Frequency Band of 900 MHz, and 1800 MHz and the Provision of Wireless Local Fixed Network with Limited Mobility at Radio Frequency Band of 800 MHz of PT.INDOSAT, Tbk...

DECIDES

To issue: **DECISION OF THE MINISTER OF COMMUNICATION AND INFORMATION TECHNOLOGY OF THE REPUBLIC OF INDONESIA ON DEFINING THE AMOUNT AND TIME OF PAYMENT OF THE LICENSE FEE OF RADIO FREQUENCY SPECTRUM OF THE THIRD YEAR FOR THE LICENSE OF RADIO FREQUENCY SPECTRUM BAND FOR THE PROVISION OF CELLULAR MOBILE NETWORK AT RADIO FREQUENCY BAND OF 900 MHz AND 1800 MHz AND THE PROVISION OF WIRELESS LOCAL FIXED NETWORK WITH LIMITED MOBILITY AT RADIO FREQUENCY BAND OF 800 MHz OF PT. INDOSAT, Tbk..**

FIRST : Fix the amount of the License Fee of Radio Frequency Spectrum of the Third Year for the License of Radio Frequency Spectrum Band (Y_3) for the Provision of Cellular Mobile Network at Radio Frequency Band of 900 MHz and 1800 MHz and the Provision of Wireless Local

Fixed Network with Limited Mobility at Radio Frequency Band of 800 MHz of PT. Indosat, Tbk.. as follows:.

- a. Radio frequency band of 800 MHz = Rp. 86,630,292,180.-
(Eighty-six billion six hundred and thirty million two hundred and ninety-two thousand hundred and eighty rupiah)
- b. Radio frequency band of 900 MHz = Rp. 734,592,765,914.-
(Seven hundred and thirty-four billion five hundred and ninety-two million seven hundred and sixty-five thousand nine hundred and fourteen rupiah)
- c. Radio frequency band of 1800 MHz = Rp. 566,116,230,826.-
(Five hundred and sixty-six billion hundred and sixteen million two hundred and thirty thousand eight hundred and twenty-six rupiah)

with the details of calculation referred to in Attachment I which is an inseparable part of this Ministerial Decision.

- SECOND : PT. INDOSAT, Tbk may make payment of the License Fee of Radio Frequency Spectrum of the Third Year for the License of Radio Frequency Spectrum Band (Y₃) referred to in the FIRST Dictum in stages since the issuance of this Ministerial Decision and shall pay up at the latest on 15 December 2012..
- THIRD : If the License Fee of Radio Frequency Spectrum of the Third Year for the License of Radio Frequency Spectrum Band (Y₃) referred to in the FIRST Dictum is paid beyond the due date of 15 December 2012, a sanction of fine is imposed in accordance with the provision of legal regulation.
- FOURTH : The payment of the License Fee of Radio Frequency Spectrum of the Third Year for the License of Radio Frequency Spectrum Band (Y₃) in stages as referred to in the SECOND Dictum is implemented in accordance with the mechanism referred to in Attachment II which is an inseparable part of this Ministerial Decision.
- FIFTH : This Ministerial Decision shall come into force on the date of its issuance.
